# Town of Chili Conservation Board Approved Minutes, November 3, 2014

The Chili Conservation Board meeting was called to order at 7:02 p.m. on November 3, 2014 at the Chili Town Hall, 3333 Chili Ave., Rochester, New York 14624.

<u>Minutes:</u> The minutes from the October 6, 2014 Conservation Board meeting were approved as submitted.

- Following a lengthy discussion about the size of the proposed houses, on a minimal lot size, the Conservation Board emphasized how important it was that a sufficient amount of topsoil be replaced to minimize potential flooding. The CB recommends at least 6 inches of settled topsoil. The contractor furnished street trees were discussed and four different varieties will be selected and forwarded to Mr. Baker. We will wait for revised prints to stamp after the Planning Board has reviewed this project.

**New Business:** R.J. Schickler and Pat Tindale discussed the list of Town of Chili Approved Street Trees and have decided to update the Town's approved Street Tree List. Some members of the Board stayed to first work on removing undesirable trees. This will be an ongoing project.
