Reports:

M.C. Environmental Council report – Dick Schickler

MC Environmental Council reports: November 20, 2019 meeting discussed the Webster wellfields that over look Lake Ontario and concerns of the water levels along the shore of Lake Ontario. Predications from the board indicate that many property owners along Edgemere Drive will be under water again this spring, as well as other properties along the shore line.

December 18, 2019 meeting was at RIT Campus and discussed pollution in New York State. Pollutions of plastic products are over running the trash companies and towns and ways the community could recycle the use of plastic products into other products to keep them out of the landfill. RIT demonstrated the use of solar panels on campus as well as green space use.

Application of Howitt-Paul Road LLC: owner:758 South Avenue, Rochester, New York, 14620 for final site plan approval to revise approval granted on April 13, 2010 to erect two three story commercial buildings (Building #1 & 2)totaling 57,870 sq. ft (19,290 sq. ft. per level) with commercial area on first floor and 17 apartment units on each of the second and third: floors: Building #3 to be a three story apartment building totaling 27,000 sq. ft. (9,000 sq. ft. per level) at property located at 751 Paul Road in RB w/PNOD zone.
