



COMMENTS OR QUESTIONS FROM THE AUDIENCE: None

SUPERVISOR DUNNING: Again, seeing no one in the audience, I will assume there is no one from the public that has any comment.

Does the Town Board have any comments?

No comments.

Very good.

The Public Hearing was closed at 7:04 p.m.

At this point, a Public Forum was conducted to allow public speakers to address the Town Board. No speakers addressed the Town Board. The Public Forum concluded at 7:04 p.m.

**MATTERS OF THE SUPERVISOR:**

SUPERVISOR DUNNING: A couple of things. Playgrounds are going in well. The guys are doing a great job getting those all assembled and getting things going very nicely over there. The rooftop units -- there's a little bit of a delay in the installation of the rooftop units. They were going to go in Memorial Day weekend. But I believe now the following week or the week after that, the first part of June, those will get replaced.

And also --

COUNCILMAN SLATTERY: Well, can I go back to the playground? When is the matting going to be put down for the playgrounds?

SUPERVISOR DUNNING: Mr. Lindsay?

DAVID LINDSAY: We don't have a specific date. There's a temperature requirement, consistent temperatures above 50 degrees. But I can get that information for you.

COUNCILMAN SLATTERY: No. That's okay. I just -- the playground equipment has been installed. That is one of the final pieces?

DAVID LINDSAY: Yes.

SUPERVISOR DUNNING: What about the status of the fitness court?

DAVID LINDSAY: Fitness court was scheduled to be going in this week, but again, we had temperature issues so we delayed it a week and we'll see what it looks like next week.

SUPERVISOR DUNNING: Very good. Thank you. And also, the Veterans Memorial, the original plan was start -- we're starting at looking almost like now but realizing Memorial Day we want to have the old Monument in place for the service. So that will take place shortly after Memorial Day and they'll start working on that. So some of the things are already in. I don't know what you call that statue with the boot and the hat.

DAVID LINDSAY: The soldiers -- I forget the actual names. But --

SUPERVISOR DUNNING: The "Soldiers Cross."

DAVID LINDSAY: "Soldiers Cross" for the middle. The stones are being worked on right now. And then generally speaking, we should be starting roughly around the first week of June and hope to be completed with that by July.

COUNCILMAN SLATTERY: Awesome. Beautiful. Thank you.

SUPERVISOR DUNNING: The other thing I wanted to briefly mention -- I don't know if you're all aware, but I know some are, with the assessments that -- the revaluations that were just done. We started looking more into the tax and how people are taxed and things like that.

So I recently drafted a letter and sent it to every single Senator, every single Assemblyperson in New York State -- a letter with a plan to -- for better ways of collecting more specifically school tax. It's done in other states. Florida, South Dakota, Tennessee to name a few, as well -- Pennsylvania has got legislation sitting in front of them right now. But you should be aware in case you do hear anything back from anybody. I sent these out a couple weeks ago now and I have actually gotten two responses.

Basically we received a "Thank you. We'll get back to you."

SUPERVISOR DUNNING: Pretty much. But it was -- I think it was a very nice -- a very well written letter, a very -- well put together and gave them a specific plan of how to do better -- how we could do better collecting school taxes and not put such a heavy burden on our residents for that particular part of their tax bill. Because that is the heaviest lift we all encounter. We all live here. We all have to deal with them. No matter where you live, you have to pay school taxes.

I'm really hoping it will gain some ground and somebody will do something with it. I know they're in session so that could change things a little bit, but that is what it is. Just want you to be aware of it in case you hear anything. If you want to see the letter, I would be happy to share it with you.

COUNCILMAN SLATTERY: I like the concept. And the back-up information you provided -- so I think if they're serious and they want to do something for the taxpayers, then you would hope that they look into it with a little more or have their staff do it.

SUPERVISOR DUNNING: I don't care who does it --

COUNCILMAN SLATTERY: Right.

SUPERVISOR DUNNING: -- as long as somebody has at -- does look into it.

So under -- I don't have anything additional.

**MATTERS OF THE TOWN COUNCIL:**

COUNCILMAN SLATTERY: Just an update on the sidewalk project for Paul Road, with the engineer. Is there any update on that?

SUPERVISOR DUNNING: Lu Engineers -- I don't know if you have any recent update. They -- they're working on it. I know that.

DAVID LINDSAY: They started some preliminary work, scheduling some of the surveying they need. I have to meet with Mr. Prior next week to go over and get a detailed schedule from them as far as the development of the plan. I will provide an update at the next meeting.

COUNCILMAN SLATTERY: Beautiful. And I see that the water main project has started on Paul Road.

DAVID LINDSAY: Yes.

COUNCILMAN SLATTERY: And then one concern that I have is they -- a couple weeks ago they went and saw-cut the road, you know, parallel with the lane. So if there is somebody on a bicycle or a motorcycle, their tires can go into the crack -- the two cracks in certain areas for the saw-cut. It's in the driving lane. So it is dangerous.

So if -- if there is a progress meeting that we can maybe mention that to the Water Authority. I think -- or their contractor Randsco.

DAVID LINDSAY: Sure. We just had a project -- a progress meeting yesterday, but I will follow up with them when I get the minutes and mention that to them.

COUNCILMAN SLATTERY: Yeah. If you take -- if you just drive down there and take a look at it, it is dangerous. Especially at nighttime if somebody comes through there. Motorcycle -- motorcycle season and so forth. They could catch that.

COUNCILWOMAN SPERR: I have seen that. You're right.

SUPERVISOR DUNNING: That's why I bought (inaudible).

COUNCILMAN SLATTERY: Well, one of the reasons.

COUNCILWOMAN SPERR: Well, you mentioned that -- Chestnut Ridge and that road. But also for people who don't know, they are going to be closing King Road at the railroad crossing the 19th through the 25th. They're going to work on that. We have detours going past my house for Widener Road bridge for 386 that is out. Just like to let people know when the roads are closed because it affects their whole route.

COUNCILMAN SLATTERY: Well, they have Attridge Road closed now -- and they have to jump over to do that. But they have message boards up so they're announcing that, as well.

SUPERVISOR DUNNING: Thanks for mentioning that. It just reminded me the northbound entrance to 390, I believe, is closing this week for a little bit. So the entrance to Scottsville Road, as well as the northbound entrance to the expressway will be closed. I believe that's this week.

COUNCILWOMAN SPERR: I did see that. Thank you.

SUPERVISOR DUNNING: Anything else, Counsel?
