Brian reported back to the Committee regarding 9 Jamie Lynn , he pointed out that the Pond in question is and always has been a Detention Pond, not a Retention Pond. As such, it is
functioning as it is intended to do. Historically, it was always shallow (1' deep) Brian pointed out that there may have been some buildup from sediments and runoff from lawns and the flow of
others parts of the neighboring homes and properties. The extent of the runoff during a rain event suggest that the limits of water rising up to the trees in the backyard is appropriate given the
design. As a result, during the early Spring months, some water level rising can be expected, and

may result in the area periodically becoming a habitat for wildlife, e.g. birds, small rodents, and frogs. Brian will follow-up with the Homeowners about any recommendations that the Town can

give regarding removing any debris or sediments that are present in the pond.
