There was a discussion of the code upgrades which are waiting for town approval and would include public hearings, and other code revisions. Our board hopes to be as least restrictive as possible.

Bonnie said there is an early morning show on Fox News Rochester Channel 7, an ABC affiliate sponsored by channel 13 and hosted by Norma Holland. Bonnie is going to contact her to invite them to do a video field of some of our landmarks. Some of our board could ride along and point out features.
