### OLD BUSINESS

Date	Issue/Concern	Discussion/Actions Taken
Aug 4, 2022 Item #1	Town citizens informed the committee that they have a concern with the intersection of Beaver Rd./Beaver Rd. Ext, and Flinton Run.	• There have been multiple accidents at the intersection of Beaver Rd./Beaver Rd. Ext, and Finton Run. This is one of the newer town intersections that involves the Rose Hill Estates development. The concerned citizens are aware that the road is a state road, and any engineering or installation of stop lights is completely at the discretion of the NYSDOT. After discussion, the committee will investigate improvements for this intersection specific to signage and sight lines. The committee will make a recommendation to the Town Highway department for any needed actions.

Dec 1, 2022 Issue #1	Committee member Tom Schreck reports that the streetlight on Union St. just south of Rt. 33A (Chili Ave.) is out and needs to be replaced.	<ul> <li>The highway department needs to be informed and committee member Schreck was asked to contact the highway department to ensure that the streetlight is fixed.</li> <li>[Jan 5] Town has reported to RGE.</li> <li>[Feb 2] Awaiting RGE to complete work.</li> <li>[Mar 2] Awaiting RGE to complete work.</li> <li>[Apr 6] Waiting for RGE</li> <li>[Aug 3] Town will call RGE to verify work completion</li> <li>[Sept 7] No confirmation on this specific light; however, comments made that there have been other lights fixed throughout the town.</li> <li>[Oct 5] Committee members will confirm if this streetlight was also included in the set of lights fixed throughout town.</li> </ul>
Sept. 7, 2023 Item #1	Concerned citizens approached the committee and expressed their concern with excessive speed on Gateway Rd.	<ul> <li>After discussions, it was decided that the area will be included for driver feedback signs; weather permitting and if not be on the rotation for Spring 2024. Additional discussion around the possibility of adding a stop sign – it was explained the process of having a stop sign added. The committee will also look to inform MCSO on adding the neighborhood for special attention.</li> <li>[Oct 5] Committee learned that County Representative, Tracy DiFlorio wrote a letter to Sheriff Baxter thanking him for the work his deputies do on a regular basis. Additionally, Mrs. DiFlorio brought to the attention the need for more patrols and traffic enforcement from the MCSO.</li> </ul>
Sept. 7, 2023 Item #2	Several committee members received complaints about the "non-right turn only lane" on Union St and Fulham PI. and that this extra lane is confusing for drivers heading southbound.	<ul> <li>Discussion was made about why this lane was stripped/painted and many agreed that it is awkward and easily confusing. There is a potential danger/safety in that unknowing drivers assume it is the right turn into Black Creek Park who then have to quickly move back over into the previous lane. It is suggested that the county look at possible restriping this lane to reduce or eliminate the confusion of the lane being a right turn only.</li> <li>Tim Harris, MCDOT, informed the committee that the county is looking into adding a merge or right lane ends sign to inform drivers that the lane is not a right turn only lane and that the lane ends.</li> </ul>
