Application of NOWAVE LLC, 350 Buell Road, Rochester, New York 14624, property owner: Rochester Cornerstone Group- RICC LLC; for preliminary site plan approval to construct a 27,000 sq. ft. manufacturing building and a 4,000 sq. ft. accessory building at property located at 300 Trade Court in L.I. district.

The Conservation Board appreciates the quality of the plans submitted and that they were created by a landscape architect. Pat Tindale made a motion to accept the plans as submitted. Seconded by Bill Steimer.
