OLD BUSINESS

Date	Issue/Concern	Discussion
Mar. 7, 2024 Item #1	A concerned citizen approached the committee to express her observation of vehicles traveling at high rate of speed Bolton Trail	<ul style="list-style-type: none"> • Committee expressed their understanding of this issue and mentioned that this was a problem throughout the town and county as well as many other municipalities. David Lindsay offered that the highway department will look into signage in the area and adding the neighborhood to the driver feedback rotation • [Apr 4] No discussion • [May 2] Awaiting placement of the driver feedback and then collecting its data. • [June 6] Feedback signs were placed but needed to be removed for servicing. Once fixed, they will be placed back up into rotation. • [Aug 1] Rework and milling is currently being done in this area; no feedback signs posted yet. • [Sept 2025] Road work and milling still ongoing and units not placed; also availability of units is limited given that they are out for update/repair. • [Oct 3] Units still out for repair and will likely not be back in service before late Fall/early winter. • [Nov 7] Town units have been returned/repared; however, late in season as these are not used during cold weather season. The neighborhood will be placed on the early spring rotation, weather permitting. • [Dec 5] Issue will remain in the minutes until the driver feedback signs are posted.
Sept 5, 2024 Item #1	Weidner Bridge (Rt. 386) remains closed	<ul style="list-style-type: none"> • NYSDOT has informed the town that it plans to have the bridge work completed and opened by the end of October. • [Oct 3] After a slight delay from technical issues, the project is still planned for end of October completion. • [Nov 7] NYSDOT continues to run into myriad issues with finalization of the project. The expectation is that the bridge will reopen end of November. • [Dec 5] NYSDOT informed the town that the bridge work has concluded and is now open to traffic.

Nov 7, 2024 Item #1	A concerned citizen inquired with the committee on the ability to place a stop light at the intersection of King Rd. and NYS Rt. 259 (Union St.).	<ul style="list-style-type: none"> • Committee advised the citizen that the intersection comes under the authority of NYSDOT and confirmed the contact for the regional office of NYSDOT. Additionally, committee will request a traffic study be conducted for this intersection to better assess if a stop light is warranted and to gather additional traffic information. • [Dec 5] Committee member, Tom Schreck mentioned that other town residents had approached him regarding this same issue and request.


Date	Issue/Concern	Discussion/Actions Taken
Dec 4, 2024 Item #1	A concerned citizen inquired with the committee on the continued issue with excessive speed along Chestnut Ridge Rd. primarily the middle section which is between Rt. 386 and Paul Rd.	<ul style="list-style-type: none"> • Committee reviewed the history and findings from recent study and that this section of Chestnut Ridge Rd. will be on the rotation for driver feedback signs. Additionally, committee advised to contact MCSO and request special attention to this stretch of Chestnut Ridge Rd.
